SteveFest will take place on Friday 2/26 through Sunday 2/28/2010 at the Charlotte County Fair Grounds on State Road 776 across from the Charlotte County Stadium. This is a 3 day event with onsite camping. Gates open:

- Friday 2/26 4:00 and run until the last featured act around 10:00 pm
- Saturday 2/27 10:00am until the last featured act around 11:00pm
- Sunday 2/28 10:00-2:00pm

Vendor hereby agrees to vend at the SteveFest pursuant to the terms and conditions set forth in this agreement. Vendors shall be ready for business by 2:30 on Friday 2/26. Load in time will begin Friday morning at 8:30 am. Your load-in contact will be Phebe Westby (cell 941-628-0578).

Vendor shall pay SteveFest 25% of gross revenue. This is a ticket only event. All items must be priced by \$1.00 tickets and clearly posted. (for example – soup 5 tickets etc.) Vendor

shall only accept SteveFest vendor tickets for products and shall not accept other forms of payment. Taking cash shall be a material breach of this agreement and shall result in expulsion from the event. At the end of day, vendors are to bring bundled in 100s counted tickets to the event office to receive cash for tickets.

Recycling is highly encouraged. We will have recycling bins that will accept plastics #1 & #2 as well as aluminum. Using these types of products if possible is suggested.

This is an outdoor event. You are responsible for any tents, chairs, tables etc. Electricity will be available. Please let us know what your electrical needs will be and how much space you will need.
